### IN SCHOOL IDLA COURSES: \$75.00 per course. (Dual Credit classes have \$0 fee)

1) Please make checks payable to Vision Charter School and write the name of the student on the "Memo" line. Checks will be held as deposit and only cashed if the student does not receive a grade of "C" or higher. For students who pass their courses, (with "C" or above), checks will be shredded. Please turn in the \$75.00 course fee with this registration in order to be processed. 2) All courses taken through IDLA will be put on the student's transcript. \*\* If a course is dropped after the IDLA withdrawal deadline, the student will receive an "F" for the course and check will be cashed. **PLEASE NOTIFY YOUR COUNSELOR ASAP IF YOU DROP YOUR IDLA CLASS!** If you withdraw before IDLA's deadline, your student receives no grade and check will be shredded. 3) Students who are not self-motivated or self-driven are not encouraged to enroll in IDLA courses. End of course **EXTENSIONS** will not be granted by the school. Students are expected to work on IDLA class work ONLY during the period and not any other work. Staff is available for assistance when needed, but is not responsible to monitor student's progress in the course.

### OVERLOAD AND SUMMER IDLA COURSES: \$75.00 per course. (HS courses not taken for remedial reasons may be paid for through the student's Advanced Opportunities fund. Dual Credit classes have \$0 fee)

Please make checks payable to Vision Charter School and write the name of the student on the "Memo" line. Checks will be cashed after the withdrawal date for classes. Please turn in the \$75.00 course fee with this registration in order to be processed. Parents may elect to not have the grade achieved by the student entered onto the student's transcript.

### ADVANCED OPPORTUNITY/FAST FORWARD student accounts can be used for overload and dual credit courses that are NOT remedial.

All courses taken through IDLA will be put on the student's transcript. \*\* If a course is dropped after the IDLA withdrawal deadline, the student will receive an "F" for the course & will have to pay for another course if s/he desires to utilize Fast Forward money. Any grade below a "C" doesn't meet VCS proficiency & students may need to retake course at their own cost.
